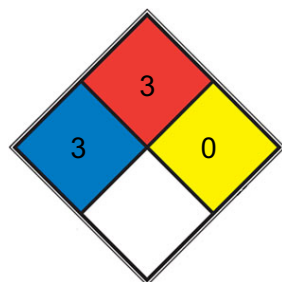
Thermal decomposition can lead to release of irritating gases and vapors. Flammable. Containers may explode when heated.

Engineering Measures
