#### Eye contact

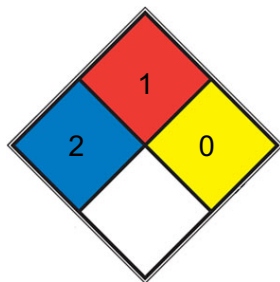
