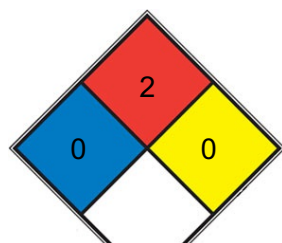

**Toxics Screening Level**

The CAS and NLM on-line literature searches for this evaluation were conducted on June 16, 2009. No toxicity information could be located for 2,5-dimethylbenzaldehyde. Due to a lack of data the screening level is being set at the default of 0.1µg/m<sup>3</sup> with annual averaging under R232 (1) (i).
