Eye Contact

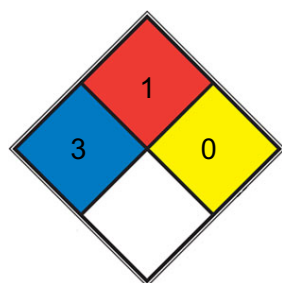
