#### Eye contact

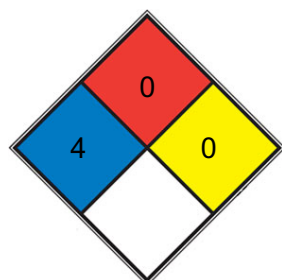
