General Advice

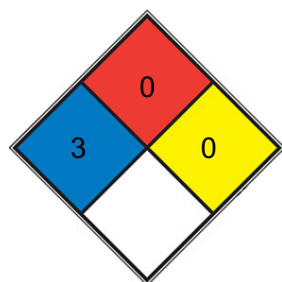
