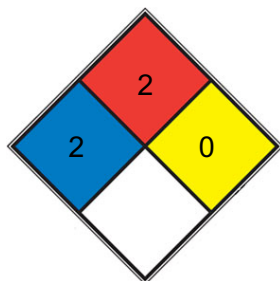
### Specific Hazards Arising from the Chemical

## Exposure Controls
