Eye Contact

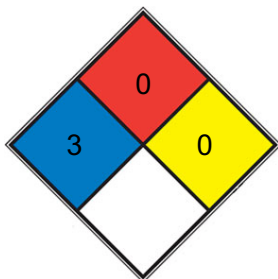
