Eye Contact

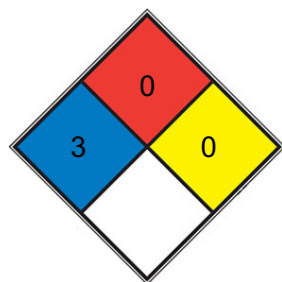
