### General Advice

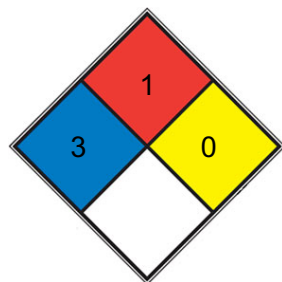
