Eye Contact

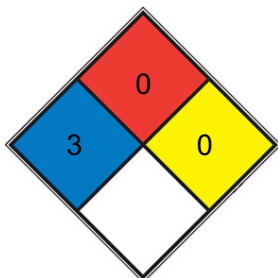
