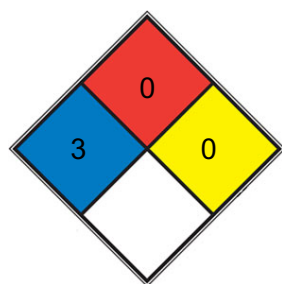

The absorption of large quantities leads to: CNS depression (narcosis). Repeated skin contact leads to a degreasing effect, with secondary inflammation possible. Toxic effects on the liver and kidneys cannot be

excluded after high doses. The inhalation of droplets may result in the formation of oedemas in the respiratory tract.
