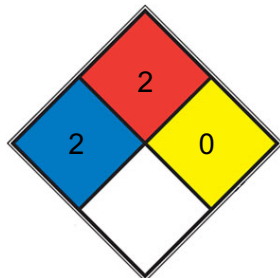
### Specific Hazards Arising from the Chemical
