If inhaled

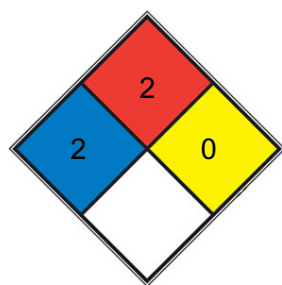

Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
