### Description of first aid measures

#### General advice

### Extinguishing media

#### Suitable extinguishing media

Foam Carbon dioxide (CO<sub>2</sub>) Dry powder

#### Unsuitable extinguishing media

### Special hazards arising from the substance or mixture

Carbon oxides Nitrogen oxides (NOx) Hydrogen fluoride Combustible.

Vapors are heavier than air and may spread along floors. Forms explosive mixtures with air on intense heating.

Development of hazardous combustion gases or vapours possible in the event of fire.

### **Advice for firefighters**

Stay in danger area only with self-contained breathing apparatus. Prevent skin contact by keeping a safe distance or by wearing suitable protective clothing.

### **Further information**

Remove container from danger zone and cool with water. Suppress (knock down) gases/vapors/mists with a water spray jet. Prevent fire extinguishing water from contaminating surface water or the ground water system.

### **Personal precautions, protective equipment and emergency procedures**
