## SECTION 4: First aid measures

### General Advice

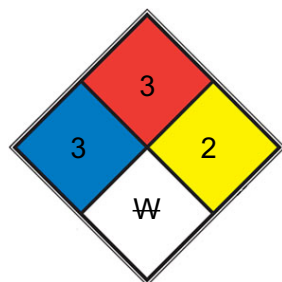
### Specific Hazards Arising from the Chemical

Thermal decomposition can lead to release of irritating gases and vapors. The product causes burns of eyes, skin and mucous membranes. Reacts violently with water. Flammable. Containers may explode when heated. Vapors may form explosive mixtures with air. Vapors may travel to source of ignition and flash back.

## SECTION 7: Handling and storage

### Handling

If swallowed then seek immediate medical assistance. Do not allow contact with water. If peroxide formation is suspected, do not open or move container. To avoid ignition of vapors by static electricity discharge, all metal parts of the equipment must be grounded. Take precautionary measures against static discharges.

### Storage

Keep refrigerated. Corrosives area. Keep away from water or moist air. Keep containers tightly closed in a dry, cool and well-ventilated place. Containers should be dated when opened and tested periodically for the presence of peroxides. Should crystals form in a peroxidizable liquid, peroxidation may have occurred and the product should be considered extremely dangerous.
