General Advice

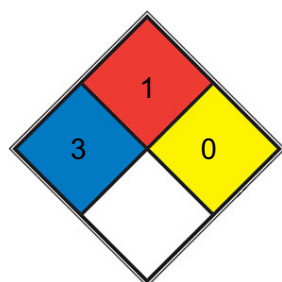
