### General Advice

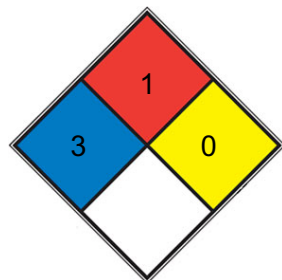
