General Advice

Eye Contact

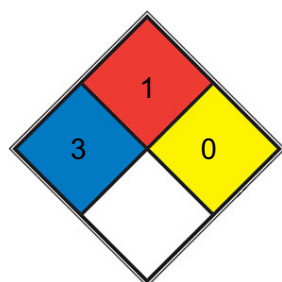
