### 4.1 Description of first-aid measures

#### General advice

#### If inhaled

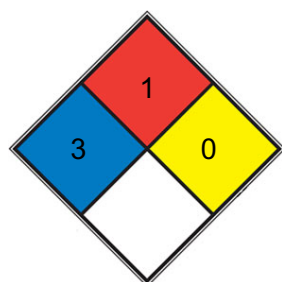

### 5.3 Advice for firefighters
