#### **Eye contact**

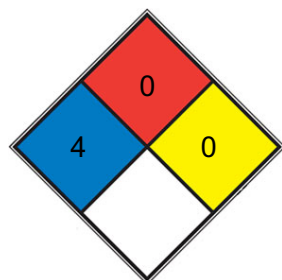
