SECTION 4: First aid measures

General Advice

Most important symptoms and effects

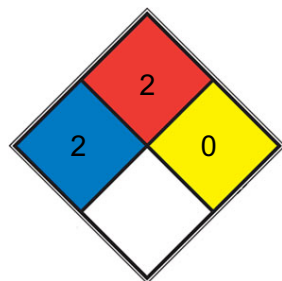
