## SECTION 4: First aid measures

### **General Advice**

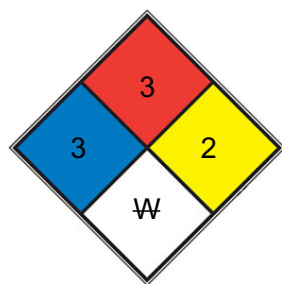
### Specific Hazards Arising from the Chemical

## SECTION 6: Accidental release measures

### Personal Precautions

## SECTION 7: Handling and storage

### Handling

### Storage
