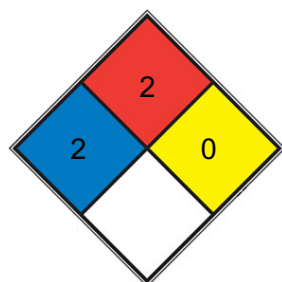

SECTION 6: Accidental release measures

The acute oral LD₅₀ value in rats was reported as 1.68 g/kg (1*46-1 -90 g/kg) (Moreno, 1973). Because of its action as a liver poison and methaemoglobin former, α -terpinene should be used very sparingly, or not at all, in foods (B?r & Griepentrog, 1967).
