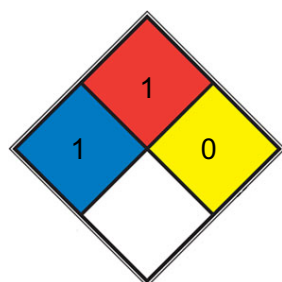

## SECTION 13: Disposal considerations

#### **Waste treatment methods**

#### **Product**

Offer surplus and non-recyclable solutions to a licensed disposal company.
