#### Eye contact

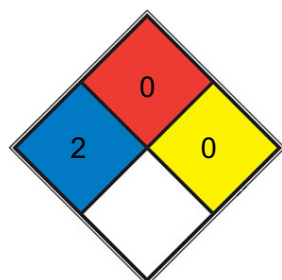
