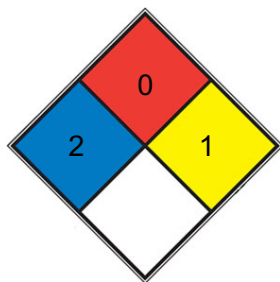

For severe cases the skin may show pimples, boils, hives, blisters and black and blue spots. Iodides are readily diffused across the placenta. Neonatal deaths from respiratory distress secondary to goiter have been reported. Iodides have been known to cause drug-induced fevers, which are usually of short duration., Ingestion may provoke the following symptoms:., hypertension, gastroenteritis, contractions of the cardiac muscles, muscular paralysis, slow irregular pulse, Vomiting, burning sensation, Cough, wheezing, laryngitis
