#### **General advice**

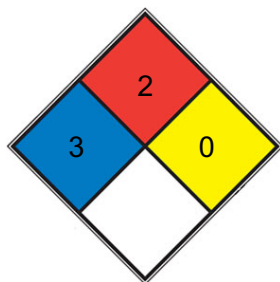
## Advice for firefighters

## Further information
