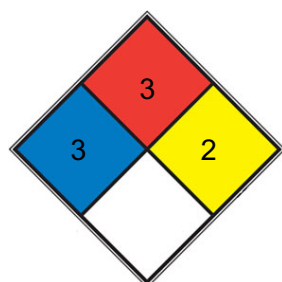

Body Protection
