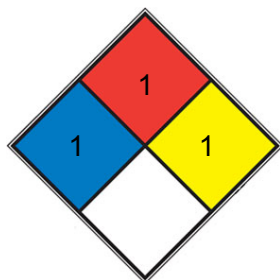

Incompatibilities

Copper dust, fume, and mists form shock-sensitive compounds with acetylene gas, acetylenic compounds, azides, and ethylene oxides. Incompatible with acids, chemically active metals, such as potassium; sodium, magnesium, zinc, zirconium, strong bases. Violent reaction, possibly explosive, if finely divided material come in contact with strong oxidizers

Waste Disposal

Copper-containing wastes can be concentrated through the use of ion exchange, reverse osmosis, or evaporators to the point where copper can be electrolytically removed and sent to a reclaiming firm. If recovery is not feasible, the copper can be precipitated through the use of caustics and the sludge deposited in a chemical waste landfill.
