SECTION 4: First aid measures

Description of first aid measures

If inhaled

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately.

Excerpt from ERG Guide 171 [Substances (Low to Moderate Hazard)]: Inhalation of material may be harmful. Contact may cause burns to skin and eyes. SECTION 6: Accidental release measures

Personal precautions, protective equipment and emergency procedures

Avoid dust formation. Avoid breathing mist, gas or vapours. Avoid contacting with skin and eye. Use personal protective equipment. Wear chemical impermeable gloves. Ensure adequate ventilation. Remove all sources of ignition. Evacuate personnel to safe areas. Keep people away from and upwind of spill/leak.

SECTION 10: Stability and reactivity

Reactivity

Thio and dithiocarbamates slowly decompose in aqueous solution to form carbon disulfide and methylamine or other amines. Such decompositions are accelerated by acids or alkalis.

Chemical stability

Stable, 50% unchanged greater than 10 yr at 70 deg c.

Possibility of hazardous reactions

Fire point: 149 deg CCYCLOATE is a thiocarbamate ester. Flammable gases are generated by the combination of thiocarbamates and dithiocarbamates with aldehydes, nitrides, and hydrides. Thiocarbamates and dithiocarbamates are incompatible with acids, peroxides, and acid halides.

Toxicity

Persistence and degradability

AEROBIC: Thiocarbamates, such as cycloate, undergo rapid biodegradation(1,4). Cycloate was not mineralized in sewage or lakewater, but it was metabolized to organic products(2). When incorporated 3 inches deep into moist loam at a temperature of 70-80 deg C, an 83% loss of cycloate occurred in 70 days; at 40 deg C only 32% loss occurred(3). In dry soil incubated at 70-80 deg C, only 9% loss occurred(3).

Autoclaving the soils greatly increased the persistence of cycloate indicating that microbial degradation is important(3). Cycloate does not decrease the number or biochemical activity of soil organisms(4). Using a continuous flow-through system and soil inoculum, 14C-labeled cycloate was up to 90% mineralized(5). Laboratory metabolism study using aerobic soil resulted in a half-life of 43 days; soil degradates include the sulfoxide and N-ethylcyclohexylamine, N-cyclohexyl-N-ethylformamide and N-ethyl-N-formyl-S- ethyl thiocarbamate(6).

Bioaccumulative potential

An estimated BCF of 190 was calculated for cycloate(SRC), using a log Kow of 3.88(1) and a regression-derived equation(2). According to a classification scheme(3), this BCF suggests the potential for bioconcentration in aquatic organisms is high, provided the compound is not metabolized by the organism(SRC).

Mobility in soil

The Koc of cycloate has been experimentally determined to be 345(1,2). The compound tends to sorb to soil under dry conditions and is not reversed if soil is later flooded(3). If already flooded, then cycloate desorbs readily and then volatilizes. Koc values of 500-800 have been reported(3). According to a classification scheme(4), these Koc values suggest that cycloate is expected to have moderate mobility in soil. Cycloate was found at a maximum depth of 6-9 inches in a leaching study using four different soils(5).

Disposal methods

Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
