4.1 Description of first-aid measures

General advice

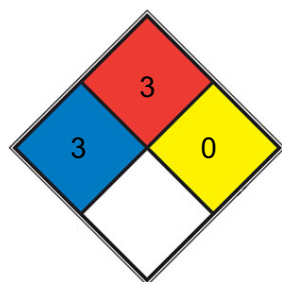

5.3 Advice for firefighters
