## SECTION 4: First aid measures

### Description of first aid measures

#### General advice

First aiders need to protect themselves. Show this material safety data sheet to the doctor

#### If inhaled

After inhalation: fresh air. Immediately call in physician. If breathing stops: immediately apply artificial respiration, if necessary also oxygen.

#### In case of skin contact

Carbon oxides Combustible.
