### Description of first aid measures

#### If inhaled

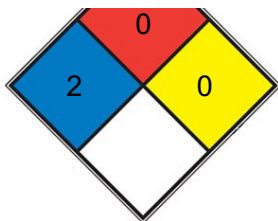
