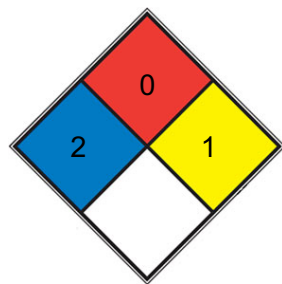

This substance/mixture contains no components considered to be either persistent, bioaccumulative and toxic (PBT), or very persistent and very bioaccumulative (vPvB) at levels of 0.1% or higher.

Toxics Screening Level

The initial threshold screening level (ITSL) for acute exposure to borates is 80 µg/m³ as boron (1-hour averaging time) based on the Michigan Department of Environmental Quality (MDEQ), Air Quality Division (AQD) Rule 336.1233 (1) and (2). With molecular weight adjustment, the ITSL for boric acid is 460 µg/m³ (1-hour averaging time).

Incompatibilities

Boric acid decomposes in heat above 100 C, forming boric anhydride and water. Boric acid is hygroscopic; it will absorb moisture from the air. Boric acid aqueous solution is a weak acid; incompatible with strong reducing agents including alkali metals and metal hydrides (may generate explosive hydrogen gas); acetic anhydride, alkali carbonates, and hydroxides.
