Do not attempt to neutralise.

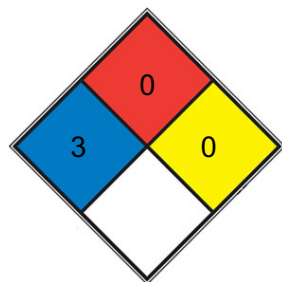
Advice for firefighters
