General Advice

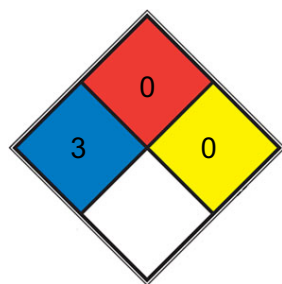
Specific Hazards Arising from the Chemical
