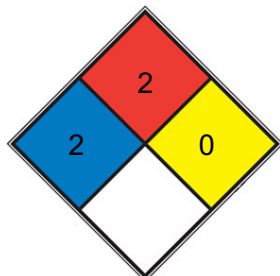
## Specific Hazards Arising from the Chemical

## SECTION 6: Accidental release measures

### Exposure Controls

#### Engineering Measures
