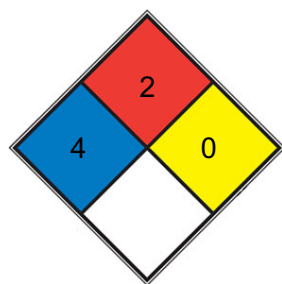
Specific Hazards Arising from the Chemical

SECTION 6: Accidental release measures

Personal Precautions
