General Advice

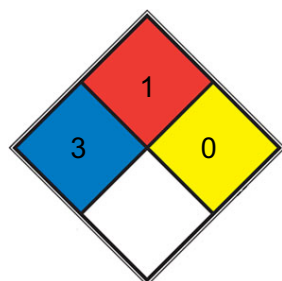
