General Advice

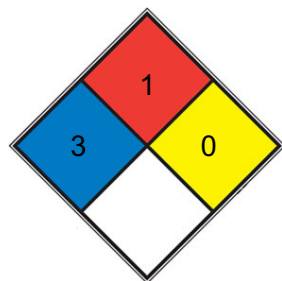
