#### Eye contact

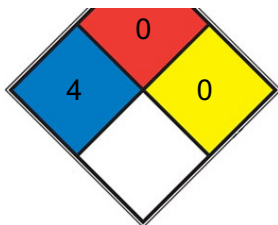
