SECTION 4: First aid measures

Eye Contact

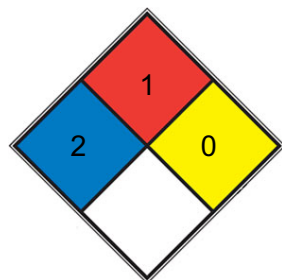
Specific Hazards Arising from the Chemical
