General advice

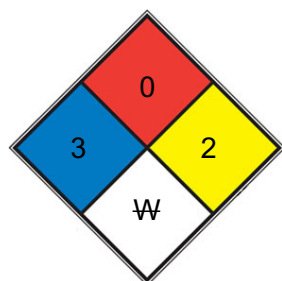
