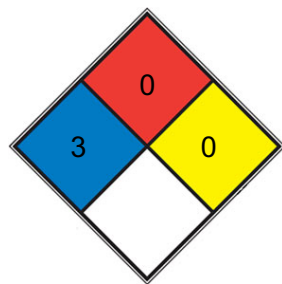

Keep away from alkaline materials, strong bases, strong acids, oxoacids, epoxides, halogens. Yttrium nitrate is a combustible material.
